Testing of Drinking Water

S. Reith wanted to inform the committee that testing has been done on the drinking water in buildings that were built before 1991. Some buildings have resulted in high testing numbers coming back and water coolers have been put in place as a safety precaution until proper filter systems can be installed.

It is suggested that people go to the Ministry of Environment website for future guidelines and read their Q&A Section to get a better understanding for the drinking water testing. JHE was tested and the results came back below the Ontario drinking water guideline. Further testing to other areas of JHE and the Annex will be conducted, and the results of this testing will be placed on the Health and Safety board in the main lobby of JHE.

- D. Keller asked where the lead in the drinking water was coming from. S. Reith informed the committee that the age of the piping system has a lot to do with it, as years ago they use to solder with lead.
- J. McLaren asked whether it is safe to drink the water in JHE and when the water coolers will be removed, as he sees the coolers being a potential problem when the students return in the fall. S. Reith indicated that the water is safe to drink in JHE, and that the coolers are a temporary solution until more filters can be installed.
