Venture Academy Camp ETB 235/236

First Aid - Burn

Incident Description:

While camp leader was using hot glue gun to connect pieces camper was holding together, tip of glue gun contacted camper's finger causing them to drop materials and flail arms. This resulted in hot glue falling on camper's hand.

Resolution:

Campers cannot handle materials while being glued

Venture Academy Camp ETB 236

First Aid – Burn

Incident Description:

Camper received minor burn from hot glue gun when prematurely reached to hold parts being glued together.

Resolution:

Campers to stand away from glue tables and wait until glued pieces have cooled.

Venture Academy Camp ETB 228

First Aid - Cut/Laceration

Incident Description:

Camper cut finger on the side of closed scissors when they were picked up.

Resolution:

Camper told to be more careful when using scissors

Venture Academy Camp – JHE Field

First Aid - Abrasion/Contusion

Incident Description:

Camper was hit in the face with soccer ball when they walked across JHE lawn to speak with someone and inadvertently walked into the middle of a soccer game.

Resolution:

UHS suggested better signage or indication of game at play as JHE lawn is not a soccer pitch

Venture Academy Camp – Brockhouse Way

First Aid - Cut/Laceration

Incident Description:

Camper walking beside sidewalk looked back to speak to friend and tripped over rock beside green electrical box. Rock cut leg. First aid given.

Resolution:

Instructors to provide more direction to campers, to make sure they are walking straight and in a safe manner.

First Aid - Burn

Incident Description:

Camper accidentally touched soldering iron which burned through glove. First aid was given.

Resolution:

UHS has suggested heat resistant and cut resistant gloves be worn and were assured this is the case.

First Aid - Cut/Laceration

Incident Description:

Camper was using wire cutter to cut wires on soldered printed circuit board (PCB) without gloves. Finger hit edge of PCB and created a small cut.
