4. Incident Reports

Presented by S. Sathiyavanthan:

Civil Engineering – JHE

First Aid – Irritation

Incident:

Gloves became contaminated while working with Sodium Hydroxide (8mole/L). Student pulled pants up with the contaminated gloves on and the residual NaOH touched the skin on the left hip and irritated the skin.

Resolution:

Reinstruction of the person involved to advise them to change gloves frequently when handling corrosives.

Mechanical Engineering – ABB

First Aid – Cut/Laceration

Incident:

Sustained a small cut to thumb while using cart to transport supplies to lab. Glass shards from a beaker that broke were on the cart (not visible). Gloves not worn.

Resolution:

Recommend using tray or container to hold the glass during transport, mandate use of gloves and revise SOP to include glass transportation information. Sign in sheet to track transported material.

Engineering – ITB

No Injury - Hazard

Incident:

Signs of mice infestation observed. The office was cleaned on Friday and Monday morning, droppings were observed. No eating or food in the office. This situation is observed for several weeks.

Resolution:

Cleaning of the space was scheduled. Orkin was informed. Orkin person had set up bait traps in the corner and ceiling.

Engineering – JHE

Medical Symptoms - Healthcare

Incident:

While trying to reach the garbage bin located close to the gas tank and x-ray, hit head on the connection to the gas tank.

Resolution:

Gas tank connection was positioned in the path, this has since been repositioned to be moved towards the wall.
